How does it work?



Thank you for your interest in a DAISI Education Group Order.

### Initial Conversation

1. We want to understand what you are looking for as this will drive our analysis. Are you looking for a deep dive into a certain subject or a forensic overview of selected schools? We do not offer a one-size-fits-all approach. Our analysis can be tailored to your needs to enable you to get the most out of the analysis reports received. This could be in person (over teams) or via email.

### Bespoke Quotation produced

2. We will create a quotation based on this conversation, so everything is explained and up to date. This will give a clear guide to the price per school and how the arrangement with yourself will work. This price per school will remain fixed but if you want to add or remove schools from the list, we can accommodate this.

### Order Processed; School/Academy List provided

3. If you are happy to proceed, you will then need to complete the order form – which includes the purchase order and data agreement – to enable processing of the order. This is for GDPR permission as you will receive the aggregated summary report and also provide a secure password for analysis transfer when this is created.
4. At this point, we will also need a full list of school /academy name, DFE number and a contact email (usually headteacher) to complete the order and to initialise the next stage of the process.

### First Contact asking for data permission

5. Once this is received, we will email all the schools/academies on your behalf asking them to complete their bespoke order form. This is for GDPR permissions and for them to create a secure password for the analysis transfer when complete. We will continue to monitor this list letting you know who has replied and who needs chasing. We are happy to chase also.

## Data requested from schools

6. We will also contact schools and send in the data required. Full instructions will be provided both about how to access and provide the data in question and also to send it to us securely. We are used to dealing with a large number of orders. Once again, we will continue to monitor the list to guarantee all schools reply and send in data. We will let you know updates throughout the process.

## Data Received - Analysis created

7. Once data received, we will create a personalised analysis for each individual school/academy and send it back direct to them. All analysis will be sent via secure email (using the password provided by each school in their permission form). We aim to produce each one within 3 days of receipt of data. Each one of the individual school/academy reports can also be sent to yourselves on request.

## High Level Summary Report created

8. Once all data received, we will then collate all the results into a FREE summary report for you enabling you to look across all areas of your cohort selection and create interventions based on common trends/needs and hard evidence. It also provides comparisons between each school and clear averages across the whole cohort. This analysis will be sent to you via secure email (using the password provided in your original permission form).
